Mustera Property Group Ltd (**Mustera** or the **Company**) is pleased to provide an update on its operational activities during the September 2022 Quarter (the **Quarter**).

### HIGHLIGHTS

1. Mustera continued with its sales and marketing campaign for the Company's flagship project, Forbes Residences (**Forbes** or the **Project**).
2. The Company secured \$10.4m in apartment sales during the Quarter for the Project.
3. Construction has progressed on the Project with the structure now complete up to level 3.
4. The schematic design progressed on the Company's McCabe Street project in North Fremantle with a development application expected to be lodged in Q4 2022.

### 1. Forbes Residences, 10 Forbes Road, Applecross

During the Quarter, construction advanced on the Company's flagship Project, Forbes Residences. The structure is now complete up to level 3 with the level 4 amenity level structure being prepared. Services installation continue through the basement and lower levels.





In addition to the construction activities the Company continued with its sales and marketing campaign for the Project. The Company sold 5 apartments which has secured \$10.4m in sales during the Quarter for the Project.

## 2. 15 McCabe Street, North Fremantle

During the Quarter the Company advanced with the development application documentation for the North Fremantle project.

The Company has progressed with the schematic design and consultant reports during the Quarter and held preliminary meetings with the design advisory committee at the City of Fremantle. It is anticipated that the development application will be lodged in Q4 2022.
